SIA Annual Subscriptions & Joining Fees

NOTES:

- A business that manufactures, distributes or supplies (B2B) solid fuel stoves, flue/chimney systems or component parts (e.g. glass, hearths, surrounds, controls, fire board/brick etc.), is eligible for the **SIA Member** category. Fees for **SIA Members** are based on annual group turnover.
- A business that manufactures, distributes or supplies (B2B or B2C) fuel is eligible for the SIA Fuel Member category. Fees for **SIA Fuel Members** are based on annual sales volumes in cubic meters.
- Chimney sweeps may apply as an **SIA Supporter Member** providing they are a member of one of the following: Guild of Master Chimney Sweeps, National Association of Chimney Sweeps, Association of Professional Independent Chimney Sweeps, ICS Chimney Sweeping Association, National Chimney Sweeping Safety Association, HETAS Approved Sweep or are listed on the [NVQ Sweep Locator](#).
- Retail businesses may apply as an **SIA Retail Group Member** or **SIA Supporter Member** and must have physical showroom premises in the UK.
- **SIA Installer Member** applicants must be a member of a recognised solid fuel competent person scheme where applicable for their country of operation.
- **SIA Members** and **SIA Stakeholder Members** can choose to pay the Annual Subscription Fee in 3 x equal instalments at 30, 90 and 150 days from date of invoice.
- A one-off joining fee is applicable to all **SIA Member** and **SIA Stakeholder Member** applications. This is payable in full on joining.
- Monthly Direct Debit payment is available to **SIA Retail Group Members**, **SIA Fuel Members** with annual sales volumes of over 2,000 m3 and **SIA Members** in the up to £1m pa group turnover category.
- All SIA memberships renew annually and a VAT invoice will be issued to all members at renewal.
- All SIA memberships are full year contracts. We are unable to offer partial refunds. Notice of cancellation terms are set out in the Articles of Association.
